## <u>President Report – Cayce Carlsson</u>

Shared that a grant committee was created at previous board meeting. Purpose is to decide how funds can be requested from PTO. Will be comprised of 5 people.

Grant committee will create and document the procedures for requesting money.

Volunteers needed: Carrie Consolvo, Amber Caver, Carrie Phillips and Merin Noonan volunteer.

Cayce Carlsson also reports a By-law Review committee has been created with the purpose to review current by-laws and determine any changes or updates that need to be made now that the PTO has grown over the past 4 years. Will review, amend and bring to a vote.

Meredith Sipes will chair; Teresa Montgomery also volunteered. Additional volunteers needed, just need to be PTO member.

Cayce Carlsson shares that board approved a motion to change the budget to provide \$1000 in funding for Panther Incentive program. The allocation will keep rewards system in place.

#### Treasurer Report – Amber Caver

Presented FBMS Budget 2015-2016 and Financial Activity Report from 9/24/15 – 10/21/15: attached Shared that the FBMS PTO is officially sales tax exempt. Will be able to provide committees with a tax exempt form.

Reports that the PTO's insurance is due for renewal.

Policy is \$2 million in general coverage, \$5000 medical, \$25,000 accidental, \$1 million officer liability, \$10,000 business projects, \$25,000 fraud.

Renewal is \$825 but 200 paid so will be \$625; also have quote from AIM for \$775.

Amber recommends the PTO stay with PTO today and accept the renewal.

\$1000 has already been budgeted for the payment.

Teresa Montgomery motions to approve the Treasurer's Report as presented.
